## **Principal's Update to Parents**

Dear Parent/Carer,

On Monday 21<sup>st</sup> February 2022 the Government published its guidance Living with COVID 19. As we return to school after a half-term break there are some notable changes regarding testing and self-isolation, as we learn to live with covid.

The government has removed the guidance for staff and students in our education setting to undertake twice-weekly asymptomatic testing.

However, we will continue to ask students to test if symptomatic. If you have any of the main COVID 19 symptoms you should order a PCR test kit to be sent to your home or book an appointment at a walk-in or drive-through test site. This can be done until 31 March 2022 as free testing will end on 1 April 2022.

If a student tests positive, we expect the student to stay at home, test on both day 5 and day 6 and only return if these tests are negative. If a student continues to test positive, the period of isolation will be extended and end on day 10 as is currently the case. After day 10 a student can return to school. We will be setting work as part of remote learning for those students who test positive for COVID and are isolating.

Therefore, although there is no longer a legal requirement to self-isolate following a positive test, Copleston staff and students who test positive are expected to stay at home and avoid contact with other people for at least 5 full days, and then continue to follow the guidance until they have received 2 negative test results on consecutive days. We expect staff and students to do this for the well-being and safety of all on the school site. We will refuse requests for students to be on site following a positive test to protect other students and staff from a possible infection. We believe this to be sensible and in the best interests of the wider school community. This is also in line with the DfE guidance which states that if a parent insists on their child attending nursery, school, or college when they have symptoms, they can take the decision to refuse the child if, in their reasonable judgement, it is necessary to protect other pupils and staff from possible infection with COVID-19. 
